- ◆ Placement testing. Testing is \$200. Assessment testing may take 3 to 4 hours; therefore, please schedule a time.

- Official Transcript/Report Cards (must contain past and current grades and be sent directly by the student's school)
- Personal Interview (interviews are available on campus or via Skype)
   (Should the student be accepted, the Office of Admissions be in contact regarding scheduling an interview)
- ◆ Graded Writing Sample (for applicants to 11th, 12th, or postgraduate years)
